Terms & Conditions

The following terms and conditions govern all use of Silver Titan Limited trading as Gauntlet Esports, (henceforth referred to as “Gauclient.com” or ‘Gauntlet’), websites, clients and all content, services and products available at or through the website, including, but not limited to, Gauclient.com Forum Software, Gauclient.com Support Forums and the Gauclient.com Hosting service (“Hosting”), (taken together, the Website). The Website is owned and operated by Silver Titan Ltd.

The Website is offered subject to your acceptance without modification of the terms and conditions contained herein and all other operating rules, policies (including, without limitation, Gauclient.com Privacy Policy and Community Guidelines) and procedures that may be published from time to time on this Site by Gauclient.com (collectively, the “Agreement”).

Please read this Agreement carefully before accessing or using the Website. By accessing or using any part of the Website, you agree to become bound by the terms and conditions of this agreement.
